The meeting ended with a vote of thanks to the chair.

General Points:

1. CAC decided that **proposed Industrial estates/Parks/SEZ with green & orange industries and without generation of industrial effluent and air emissions** as claimed by Project Proponent shall be granted Consent to Establish in RED category as per CPCB categorization of industries irrespective of the category of individual industry without industrial effluent generation and air emissions.
2. CAC decided that plain revalidation of C to E for industries/infra projects shall be granted by just accepting a plain request letter in a format prepared by Board along with requisite consent fees as per GR of 2011

based on the present revised Capital Investment of the project where there is no change in the project from earlier C to E.

Such revalidation of C to E shall be accorded from the date of expiry of previous C to E for a period upto 5 years or commissioning of the project whichever is earlier. AST and CAC cell shall jointly prepare a format for request letter to be obtained from PP and procedure to issue revalidated letter.

3. CAC reiterated its decision of grant of combined consent and BMW authorization and it was decided that hereafter consent application either of industry or hospital etc shall be taken up jointly with consent.
