The case was placed before CAC dtd-27/12/2012.

- It was decided to issue SCN for refusal.
- Accordingly SCN dtd-08/01/2013 was issued to the industry.
- SCN was issued for Non submission of required data for ascertaining No Increase in pollution load viz:-
 - 1) Your pollution Load Assessment report shows that Industrial effluent quantity is increased from 1690 to 3160 CMD & reported that due to low COD of effluent total load will not be increase, however it is not supported with analytical reports & its calculations.
 - 2) No Increase in Pollution Load for air emission, effluent generation and Hazardous waste generation doesn't support with actual analysis results.
 - 3) In support of No Increase in Pollution Load you have not submitted material balance.
 - 4) Domestic effluent is increased from 122 CMD to 220 CMD which is not taken in account of justification of No Increase in Pollution Load assessment.
- Industry submitted reply to SCN vide letter dtd-14/02/2013.
- The reply submitted by the proponent to SCN issued doesn't give clarity about Computation of pollution load.
- Due to proposed product mix there is increase in effluent & sewage quantities.
- Environment Statement of the year 2010-11 and 2011-12 clearly indicates increase in process water and raw material consumption per unit of product compare to previous years.
- In this case through the proposed product mix quantities are within the previously granted consent the effluent and sewage quantity is increase, hence as per Ministry of Environment and forest circular dtd-14 dec.2006 about product mix we may not consider the case for Product mix.
- It seems that the location of the proposed activity is close to Notified River Kundalika in A-II class, Hence it is proposed to obtain distance certificate from Executive Engineer irrigation department.
- To have further clarity, it is suggested to refer the case to NEERI for assessment of pollution load due to proposed product mix.
- Submitted for taking suitable decision in CAC.
