1. Applied for consent to establish for expansion project of coal based thermal power plant of 660 MW.
2. Said project is about 0.5 km from notified river Godavari, hence not satisfied RRZ policy.
3. Environment clearance is required for proposed project.
4. SRO Nashik reported that Local Body namely Grampanchayat namely Eklahare has not given NOC to proposed expansion project.
5. Capital Investment of the proposed expansion project is Rs.4390/- crores. Consent fee details are not furnished by the SRO, Nashik.
6. ESP is proposed to coal fired boiler.
7. Compliance of existing unit for consent conditions along with monitoring results are not furnished.
8. The site is located at about 0.25 km from Godavari river hence not satisfying RRZ Policy.
9. The site is located in the existing T.P.S. Nashik.
10. This case was discussed in the CAC meeting dated 27.12.2012 it was decided that industry shall get the assessment on No increase in pollution Load from NEERI. Industry has submitted reply vide letter dated 01.02.2013. Copy of reply letter is enclosed.
11. Industry has submitted report of M/s MITCON which shows there is increase in pollution level as compared to existing power plant.

We may refer the report of M/s MITCON to NEERI for their comment.

Discussed in CAC dated 22.3.2013 and it was decided to issue SCN for refusal of consent to Establish (Expansion) for not satisfying the RRZ policy. Industry vide letter dated 19.04.2013 submitted the reply of SCN. SRO Chandrapur vide e-mail dated 06.05.2013 submitted present status report. The unit is not satisfying RRZ policy hence we may refuse the consent to establish for expansion.

Industry had applied for Consent to Establish for Expansion. At present industry is having valid consent to Operate up to 30.9.2013. Industry is engaged in manufacturing of Pharmaceutical products. RO Kalyan had recomanded for grant of consent to establish subject to MIDC NOC and Environemntal Clearance.

The case was discussed in CAC meeting held on 31.1.2013 and it was decided to grant consent to establish (Expansion) by imposing condition of EC for additional new products and NOC from MIDC. As per the internal remarks in the said minutes, SLO to verify whether High Court decision is applicable in this case or not.

Accordingly consent DFA has been prepared and forwarded the file to Legal section for comments on internal remarks. I/c. LO in their remarks mentioned that, Considering the CPCB's directions, non compliances of Addl. Ambernath CETP & CETP matter pending before the High Court, Mumbai; we may not consider the application for grant of Consent to Establish (for expansion) at this stage.

Member Secretary is of the opinion that the case shall be put up before CAC for taking appropriate decision in the matter by CAC.

1. Industry had submitted application for grant of Consent to Establish for expansion of existing unit for mfg. of additional 13 Nos. of Bulk Drug products.
2. SCN was issued on 19/04/12 for not responding to Board's letter dtd. 11/11/11 & 25/01/12.
3. Personal hearing was extended on 20/06/12 after receipt of reply dtd. 9/05/12.
4. Case was discussed in CAC dtd. 24/12/12 and it was decided to issue SCN for refusal.
5. W.r.t. SCN dtd. 15/01/13, industry has submitted revised proposal vide letter dtd. 7/03/13 to manufacture only 6 Nos. of products in place of earlier proposal of 13 products on campaign basis alongwith No increase in pollution certificate.
6. CPCB vide dtd. 2/09/08 & 25/09/12 directed the Board not to permit expansion/establishment of the industrial units in areas where the associated CETPs are not complying with the required standards, where such CETPs are not complying with the required standards and such CETPs do not have adequate hydraulic load capacities.
7. Hon'ble High Court, Mumbai in PIL No. 17/2011 directed 5 CETPs including Tarapur CETP to ensure that the effluents being received from the Chemical industries meet with inlet norms for the CETP; so that after the treatment, the CETP is able to treated effluent within the permissible norms.
8. SRO has recommended to grant of Consent to Establish subject to EC, TEPS CETP's NOC, and with Zero discharge.
9. This is case for expansion in existing unit for bulk drug product. The project proponent has submitted reply to the SCN issued. Now, proposes to reduce the number of products to 6 Nos. instead of earlier 13 Nos., thereby reduction in effluent quantity and ensured to restrict the Consented quantity only to CETP. However, from no increase in pollution load certificate submitted by the industry, it seems that there is increase in pollution load due to proposed products, hence attracts EC.

In view of above, we may consider the case for grant of Consent to Establish by imposing following conditions-

- (i) To obtain EC,
- (ii) To achieve zero discharge by 100 % recycle & reuse of treated effluent,
- (iii) To provide water meter systemat ETP outlet alongwith lock & key arrangement,
- (iv) To restrict effluent discharge to CETP as per Consented quantity of 1.3 m³/day (ind. eff.) & 1.8 m³/day (dom. eff.),
- (v) To submit B.G. of Rs. 5.0 Lakh towards not to take effective steps for expansion till EC is obtained.
