HOD Remarks :-

- Applied for consent to establish
- Application received at SRO- Satara on dtd 09/03/2012 and at HQ on 29/05/2012.
- Industry has obtained consent to establish for phase I on dated 21/12/2010
- Industry located @ 1.25 KM away from A-II River Nira. Satisfy the distance criteria.
- Generation of industrial effluent will be 108 (existing 617 CMD)for which proposed to provide Effluent treatment plant consisting of RO followed by multiple effect evaporation.
- Domestic effluent generation will be NIL
- Industry has proposed to provide alkali scrubber to acid emission stack, VOC emission stack and LPG boiler stack with an adequate height
- Hazardous will sent to CHWTSDF
- RO Pune has recommended the case for grant of consent to establish
- The case was discussed in CAC held on 03/07/2012.it was decided to resubmit the case after verification of industry categorization
- We may grant the consent to Establish for Phase-II in **Orange category** with amalgamation of Consent to Establish of Phase-I.
- We may place the consent application before CAC for further consideration.

HOD Remarks :-

1. Applied for grant of consent to 1st operate.
2. Application for grant of consent to operate received to HQ on 17.07.2012.
3. Industry has paid consent fees Rs.1,50,000/- as per revised G.R.25.08.2011.
4. This case was discussed in CAC meeting held on 21.07.2011 .In this meeting it was decided to communicate industry to obtain Environmental Clearance from GoM.
5. Industry has submitted copy of Environmental Clearance dated 30.06.2012 for 4 MW gas based Captive power plant from GoM.
6. Analysis results of the JVS samples are within consented limits.
7. Industry has paid water cess up to 30.01.2012.
8. Industry has submitted copy of Environment statement for period April-2011-March-2012.
9. SRO- Raigad has recommended case for grant of consent to operate.
10. Consent to operate may be granted up to 31.03.2015.

CAC Item No. 03

HOD Remarks:

1. Applied for consent to Establish for expansion in coal production from 2.20 Million Ton/Annum to 3.50 Million Ton/Annum.
2. Board has granted consent for Existing Coal Mine for production of 2.20 Million Ton/Annum which is valid up to 31.10.2014.
3. Sub-Regional Officer, Chandrapur reported that mine lease boundary is about 0.544 km from notified river Wardha (A-II Class), thus not satisfying RRZ Policy.
4. Public hearing for expansion for 2.20 MTPA to 3.5 MTPA was conducted on 10.08.2011.
5. Capital Investment of the proposed expansion unit is Rs.319.96 Crores. Consent fee of Rs.6,39,940/- is paid by the industry. However, industry required to submit the Consent to Establish fee for increase in production of mineral 1.3 MTPA Rs. 5,2,000/- as per new GR dated 25.08.2011.
6. Domestic Effluent-489.67 CMD. STP proposed to be provided. Treated effluent will be disposed in river. Industrial Effluent-17186 CMD. Mine water will be discharged in to river.
7. Fixed water sprinklers will be provided to coal handling plant and haul roads.

Discussed in CAC meeting held on 29.5.2012 and decided to issued Show cause notice for refusal of consent for not satisfying RRZ Policy. Accordingly, SCN issued to the industry vide letter No.3567 dated 08.06.2012. Industry replied to the SCN on 04.07.2012 stating that Mining Industry is not included in RED category and RRZ Notification is not applicable to the Coal Mining Ind.

We may not consider the representation of company as per notification RRZ is applicable to all Red category Industries. Hence we may refuse the consent for expansion.

CAC Item No. 04

Bhusawal Thermal Power Station, Unit No. 2 & 3

Dist: Jalgaon.

HOD Remarks : -

1. Applied for renewal of consent for 2 x 210 MW coal based thermal power plant.
2. Earlier consent for electricity generation 482.5 MW (2 x 210 & 1 x 62.5 MW) was valid up to 31.12.2011.
3. Capital investment of the existing power plant Unit no.2 & 3 is Rs.366.59 Crores. Industry has paid Consent fee of Rs.7,33,180/- as per new GR dated 25.08.2011 for the period up to 31.12.2012.
4. Domestic Effluent – 1800 CMD. STP provided. Industrial Effluent – 7000 CMD. ETP provided.
5. JVS analysis results of effluent are within limit.
6. ESP provided to unit no.2 & 3.
- 7. Stack monitoring results are exceeding the standards limit.**
8. Fly ash is disposed to cement manufacturers.

Earlier the case was discussed in CAC dated 29.05.2012 and it was decided to issue Show Cause Notice for refusal of consent for non-compliance of consent conditions. Accordingly, Board has issued SCN vide letter dated 20.6.2012. Industry has submitted their reply vide letter dated 30.6.2012. We may grant renewal up to 31.12.2012 with the following conditions

- 1) Industry required to upgrade the ESP of Unit II & III so as to achieve consented standards.
- 2) Industry need to install modernize Ammonia Flue Gas conditioning system to Unit 2 & 3.
- 3) Industry required to install additional 3 CAAQMS in BTPS premises.
- 4) Industry need to install continuous online stack emission Monitoring within 4 months period to unit 2 & 3 stack.
- 5) Discharge of Ash Slurry effluent into Tapi river shall be stopped immediately and provided proper/adequate full proof system for Ash Slurry handling and disposal.
- 6) Nimbhora Ash bund which is located at 1.0 km from Tapi river bank which need to be shifted at suitable location to prevent any discharge/seepages.
- 7) Ash handling system need to be improved

Also the unit shall submit the Bank Guarantee of Rs.5.0 Lakhs each against the completion of work mentioned at 1 to 7 above within one year period.

CAC Item No. 05

HOD Remarks :-

The case was discussed in CAC meeting held on 03/07/2012, it was decided to grant the consent to Establish to industry subject to applicant shall not take any effective steps before obtaining Environmental/CRZ Clearance.

Now this office is receipt of letter dated 09/07/2012 from said industry in which it is stated by industry that as per EIA Notification 2006 and subsequent amendments, the proposed environmental friendly activity of Closed Conveyor System is not listed in the notification, hence do not require Environmental clearance from MoEF.

Hence we may delete the condition of EC & grant Consent to Establish subject to MCZMA condition only.

HOD Remarks :-

- Applied for renewal of Consent.
- Application received at SRO on 09.01.2012 and at HQ on 02.04.2012
- As per CMS module Closure direction was issued to industry on 11.11.2011 for non compliance of consent condition & restart direction was issued on 18.12.2010.
- Industry has provided primary, Secondary & tertiary treatment ETP
- The treated effluent is recycle/reused for ash handling and dust suppression & achieved Zero Discharge as per consent condition. But as per SRO report industry is discharging the treated effluent outside the factory in own irrigation land.
- Industry has provided Electrostatic Precipitator (ESP) to the Boiler with 50 Mtrs. Height of chimney as an APC system
- JVS analysis results dated 29.06.2011, 24.10.2011, 17.09.2011, 5.1.2012 & 15.2012 are exceeding the consent parameter
- Industry has not provided dust collection system & automatic water sprinkling system for coal handling plant.
- SCN was issued as per the CAC decision dated 16.4.2012 for not achieving ZERO discharge, not providing dust collection system, automatic water sprinkling system for coal handling plant, discharging treated effluent outside the factory premises
- RO Kolhapur has reported that industry has provided ETP comprising of primary, Secondary & tertiary treatment. The treated effluent (85 % to 90 %) is reused in the process & remaining (10 to 15 %) treated effluent is used for irrigation in their own land. Industry has provided dust collection system to coal handling section. Industry has provided water sprinkling arrangement by tankar with spray gun & automatic water sprinkling arrangement to coal handling section.
- Recommended for refusal of consent as JVS not meeting and not achieving ZERO discharge.

HOD Remarks :-

- Industry has applied for Consent to Operate (Renewal) with expansion & C to 1st O for 15 MW Co-Generation unit separately
- Application received at SRO on 18.11.2011 and at HQ on 03.01.2011.
- It is a Sugar & Co- Generation unit.
- Industrial effluent generation is 28 CMD & Domestic effluent generation is 08 CMD from Co-Generation unit.
- Industry has provided Effluent Treatment Plant with primary & secondary system
- The treated effluent is used for gardening/irrigation.
- The case was discussed in CAC meeting dated 31.1.2012.
- It was decided to grant plain renewal of consent of sugar with Bank Guarantee of Rs. 05 Lakh & Rs. 2 Lakh. & Also it was decided to issue SCN for refusal of consent for expansion (Sugar & Co-Generation) as industry is not complying the existing consent condition & consent shall be amalgamated only after compliance of these consent conditions.
- Consent for plain renewal of sugar is issued to industry on 6.2.2012 & SCN for refusal of consent for expansion (Sugar & Co- Generation) was issued to industry on 4.2.2012 as per the CAC decision dated 31.1.2012.
- The case was resubmitted in CAC meeting dated 2.3.2012. Industry has not submitted the reply of this SCN issued. In CAC meeting dated 2.3.2012 it was decided to refuse the consent for expansion of sugar & Co- Generation as industry has not replied to SCN issued by Board dated 4.2.2012
- The consent to Operate for expansion of Sugar & Co- Generation was refuse on 14.3.2012 as per the decision of CAC dated 2.3.2012.
- Now industry has submitted the letter dated 6.6.2012 & informed that
 - Industry has submitted the Bank Guarantee of Rs. 5 Lakh & Rs. 2 Lakh.
 - As per the consent to establish condition of co generation plant industry shall provide ESP to Co- Generation Boiler. Industry vide letter inform that they have not installed separate Boiler for Co- Generation Plant but only existing upgraded Boiler of Sugar industry used for Co-Generation Plant.
 - Regarding ESP to existing Sugar industry Boilers, industry has informed that it is not possible to erect ESP system to existing boiler due to very less space (14 Mtr) in between air heater to Chimney.

- Industry has requested for grant of permission of installation of wet scrubber instead of ESP & for that industry has already floated tender notice in News Paper dated 3.11.2011 for the supply, erection & commissioning of wet scrubber for existing boiler. Also they have assured that they have taken responsibility for performance of wet Scrubber.

Submitted for reconsideration of refusal by obtaining fresh fee & imposing BG of Rs. 5 Lakhs for providing wet scrubber in next six months to existing boiler..
