1. All HOD's shall submit Bank Guarantee compliances separately in next two days. Similarly follow up action shall be given in CAC agenda.
2. All the auto renewal cases shall be put up to next CAC meeting dt. 5.2.2013 for post facto approval.
3. The clarification is required on Board's circular of 2009 regarding validity period of 5 years of C to E where C to O for part is granted within validity period of EC and where industry has applied for C to O for remaining part after validity period of EC. Also SLO shall seek clarification from MoEF about validity of EC.
4. CAAQMS general policy to be finalized in next CAC meeting.
5. The discussion was held on scrutiny sheet and consent template along with variable sheet in details. It was decided to incorporate the suggestions made by the members in the scrutiny sheet. Also decided to have separate discussion on

the issue with all HOD's and Shri Rakesh Kumar, Scientist & Head, NEERI, Mumbai on 1st Feb 2013. The outcome of the same shall be put up in next CAC dtd. 5/2/2013 with five valuation sheet for validation.
