Chairman of the committee welcomed the members of the committee and allowed proceeding of the meeting to start. The minutes of 23<sup>rd</sup> Consent Appraisal Committee meeting held on 9.12.2014 circulated vide letter no. MPCB/ CAC cell/minutes/B-5220 dtd 17/12/2014 were confirmed.

The BG obtained for TWO1:- Towards O & M of Effluent Treatment Plant, TAO1:- Towards O & M of Air Pollution Control Devices and THM1c:- Towards Maintaining Records shall not be returned as it is a continuous compliance process.
