Further, CAC discussed on following points;

1. It was decided to take the review of all CAC cases in next CAC meeting whose decisions kept in abeyance.
2. The legal matrix was further discussed CAC suggested to re-group the categories of the compliance has
  - a. Substantial Compliance : More than 75%
  - b. Partial Compliance : 25 to 75%
  - c. No Compliance : Less than 25%

CAC also suggested that incremental top up of the bank guarantee should be defined to encourage the compliance. The directions for a particular non-compliance can be extended maximum upto 3 times and thereafter RO/SRO shall submit a proposal for closure / disconnection and prosecution.

CAC also discussed the implementation and roll out of this legal matrix and it was decided that initially this matrix should be put in the public domain and industries can be given limited time to voluntarily disclose their non-compliance and submit time bound action plan as per the legal matrix. In such case, bank guarantee can be waved as an encouragement for the compliance. The various non-compliances were also discussed and it was proposed that these non-compliances can be interlinked as supplementary or complimentary. In case of



complimentary directions, only one bank guarantee which is maximum can be taken. In case of supplementary category, the bank guarantee equivalent to addition of the respective non-compliances shall be taken.

3. The issue of taking returnable/ refundable deposits in lieu of BG was also discussed. It was decided to separately examine the issue in consultation with the CAO and put up in next CAC.

The meeting ended with vote of thanks to the Chair.
