Further, CAC discussed on following points;

- i) It is decided that HODs shall take review of Bank Guarantee compliances and other action points and submit action taken report of the same on monthly basis to CAC.
- ii) The consent termination date for sugar industry shall be consider 31st July as decided in earlier CAC meeting. Similarly this practice shall be followed for all type of industries and identified dates shall be put up in next CAC by JD(PAMS).

The meeting ended with vote of thanks to the Chair.

Minutes in respect of Review Item No.5
Of the 9th CAC held on 8/1/2013

A personal hearing has been extended to M/s.Built Graphic Paper Products Ltd. in respect of various conditions imposed in the consent granted to it dtd.03/01/2012 as per the order passed by the Appellate Authority in the Appeal preferred by the company aggrieved by the forfeiture of the bank guarantees and therefore, the Appellate Authority remanded back the issue for extending further hearing and then to impose appropriate conditions on the basis of the status of compliance being reported by the company and duly accepted by the CAC. Draft minutes of personal hearing enclosed separately.

The company representatives specifically agreed to restrict their grievances to 'a', 'b', 'c', 'd', 'h' & 'k' points compliance status statement submitted by them on 8/1/2013 duly signed by Gen.Manager Shri S.K. Sharma.

It was confirmed by the company representatives that their representation is limited to the 5 points, which have been discussed in the Consent Appraisal Committee meeting and with regard to the other conditions imposed in the consent conditions, they do not want to raise any objections.

After extending personal hearing, the following decisions are taken in respect of forfeiture of bank guarantee/s about the conditions imposed in the consent to operate dtd.3/1/2012 on the various conditions for which, bank guarantees were forfeited, as under :-

- (i) It was decided that since the company has not provided adequate capacity garland drain with a collection tank for inactive dump area, the decision taken in respect of forfeiture of 50% bank guarantee is to be continued and confirmed.
- (ii) As far as providing proper retaining walls or a grid of retaining walls, the committee has come to the conclusion that since, the compound wall has been provided and in the nearby forest area, retaining wall could not be provided without permission of the Forest Deptt., the decision to forfeit the bank guarantee for not providing proper retaining wall should not be enforced till Forest Deptt. grants necessary permission for that.
- (iii) About the construction of the compound wall on the back side of the lime dump near forest land with buffer zone, it was decided that since within the area allotted to company, the compound wall has not been constructed, the forfeiture of the bank guarantee is confirmed for the reasons recorded during the personal hearing extended to them.
- (iv) Since, the industry has not provided/ developed secured landfill site even though it has purchased 5 acres of land, the decision about the forfeiture of bank guarantee is confirmed.
- (v) Since, the industry has taken substantial steps for removal of colour and it requires sufficient time to study the proper adoption of technology for colour removal, it was decided that the forfeiture of bank guarantee for the non-compliance of this condition is withdrawn and the industry has been granted six months time for doing appropriate study and thereafter to submit appropriate proposal for implementation of the said technology.
