Minutes of 10th Consent Appraisal Committee Meeting of 2011 held on 19.10.2011 at 11:00 Hrs. at Conference Hall, MPC Board, Kalpataru Point, 4th Floor, Sion Circle, Sion (E), Mumbai 22.

The Consent Appraisal Committee meeting of the Board held on 19.10.2011. Following members of the Consent Appraisal Committee were present:

The Secretary, Home (Transport) Dept., Mantralaya, Mumbai, Member could not attend the meeting. Leave of absence was granted to him.

Chairman of the committee welcomed the members of the committee and allowed proceeding of the meeting to start. The minutes of the 8th and 9th Consent Appraisal Committee (CAC) meeting of 2011 held on 05.10.2011 and 12.10.2011 circulated under Board's letter No. B-5687 dated 12.10.2011 and B-5738 dated 13.10.2011 respectively were confirmed. The follow up action report of CAC meetings held earlier on 21.09.2011, 30.09.2011, 05.10.2011 and 12.10.2011 were placed before the CAC and noted.

The meeting thereafter deliberated on the agenda items placed before the committee and following decisions were taken.

Thereafter, CAC discussed the following points;

1. The consents shall be disposed after obtaining necessary consent fee difference from the industry as per GoM, Revised Consent fee structure dtd. 25.08.2011.
2. The area distribution in HOD's for the consent management is already circulated and it is necessary that the cases are marked by SRO/RO accordingly. It was noticed that many cases are marked incorrectly. It was decided to issue fresh instructions to SRO/RO and also, the HOD's shall examine the received applications and in case of wrongly marked applications, the applications shall be sent to designated section in 3 days.

Presently, all the consent application which requires Environmental Clearance are dealt by AS(T) section. This was discussed in detail and it was decided that these cases will now be dealt by concerned HOD's i.e. PCI-I,II & III etc. In case, they require technical support, specific cases can be routed through AS(T) Section.

3. During the discussion on M/s. Avantha Power, Chandrapur, Committee was informed that the installation of CAAQM station generally requires four months period. Hence, CAC decided to follow this time frame in all such cases.
4. CAC discussed the consent processing for isolated storages. It was felt that there is a need of issuing guidelines to all the ROs/SROs for processing of applications which can include; identification of isolated storages, points to be covered in processing such as availability of on-site and off-site disaster management plans, control of emissions etc. RO (HQ) to issue suitable guidelines in next 15 days.
5. Member Secretary informed that Board has given permission for trial run for some industries and has asked for the inventory of the same. It is necessary to prepare inventory of such permissions in next 15 days and ensure that these industries have

- applied for necessary consent to operate. HODs shall compile the information and submit compliance report.
6. It was decided to place all pending cases of sugar and distilleries in next CAC along with detailed compliance including trends of JVS results.
 7. CAC discussed the consent processing for construction industry and it was decided that suitable guidelines for processing the consent applications need to be issued urgently which can include :
 - a) Check list of required documents: CC / IOD, Approved layout, location map etc.
 - b) The pollution related aspects which needs to be critically reviewed i.e. STP, recycle, air pollution, MSW etc.
 - c) The debris generation, transport and disposal
 8. The next CAC meeting is scheduled on 02.11.2011.

The meeting ended with vote of thanks to the Chair.
