Minutes of 15th Consent Committee Meeting of 2014-2015 held on 10.10.2014 at 11:00 a.m. at 4th Floor Conference Hall, MPC Board, Kalpataru Point, Sion (E), Mumbai 22. (Booklet No. 28)

- Dr. B. N. Thorat, Joint Director (Air Pollution Control), Member and Principal Scientific Officer, Sp. Invitee could not attend the meeting. Leave of absence was granted to him.

Chairman of the committee welcomed the members of the committee and allowed proceeding of the meeting to start. The minutes of the 13th (Booklet No. 23 & 24) Consent Committee meeting of 2013 held on 06.08.2014 circulated under Board's letter No. MPCB/AS (T)/TB/B-4492 dated 09.09.2014 were confirmed.

The meeting thereafter deliberated on the agenda items placed before the committee and following decisions were taken.

The meeting thereafter deliberated on the agenda items (Book-let no 28.) placed before the committee and following decisions were taken.

The compliance points in respect of Sugar industry are as follows

1. Waste water to be below 100 l/ton of Cane crushing
2. Flow meter for effluent to be provided
3. ETP up-gradation
4. Arresting ingress of bagasse in effluent stream
5. Having adequate land for effluent disposal
6. Provision of adequate APC
7. Utilization of fly ash

Based on the above compliance points, compliance rating from R 1 to R 4 has been framed. It was decided to take the decision about consent renewal based on compliance rating. It was also decided to consider mainly point no. 1, 3 and 6 above for the compliance rating.

Actual verification of compliance of point no. 1 depends on the compliance of point no. 2. It was noted that the compliance of point no. 2 is not at all satisfactory. Similarly compliance of point no. 3, not only depends on the physical provision of ETP but also on design based on techno-feasibility report, proper operation and maintenance of ETP. It is, therefore, felt necessary to prescribe a condition about carrying out performance evaluation study of ETP. Accordingly the cases put up before the CC were considered with the above mentioned criteria for compliance rating.

1. It was decided to grant renewal of consent for a period upto 31.07.2015 to those industries falling in category R-1 (Totally complied industries = 2 nos) having compliance status as on 30.09.2014
2. It was decided to grant renewal of consent for a period upto 30.04.2015 to those industries falling in category R-2 (Substantially complied industries = 5 nos) having compliance status as on 30.09.2014
3. It was decided to issue SCN for refusal for renewal of consent and forfeiture of BG for non-compliance in respect of upgradation of ETP and/or APCs for the industries falling under the category of R-3 (21 Nos) and R-4 (5 nos) (total = 26 cases) as on 30.09.2014. The reply from the industry regarding the SCN should reach the office within 7 working days. If the reply submitted is not satisfactory or reply is not received within seven working days, respective BGs shall be forfeited and directions shall be issued with BG of Rs 15 lakhs for upgradation of ETP and Rs 15 lakhs for upgradation of APCs and with time period upto 30.06.2015.
4. It was also decided to issue SCN under the signature of JD(WPC).

The meeting ended with vote of thanks to the Chair.
