Chairman of the committee welcomed the members of the committee and allowed proceeding of the meeting to start. The consents shall be disposed after obtaining necessary consent fee difference from the industry as per GoM, Revised Consent fee structure dtd. 25.08.2011.

It has been observed that application for consent to establish and operate in the purview of HOD, MS, CC, Chairman and CAC are unnecessarily pending with concerned SRO/RO in the name of processing and thereby it is not possible for Board to grant consent / dispose off consent application within 4 months (120 days) of statutory period. Therefore, the industries are taking the advantage of deemed consent and most of times for not granting consents the image of the Board is unnecessarily damaged.

After due deliberations in the number of CACs, it was decided that now the necessary procedure will be established for quick disposal of consent application within statutory period. Therefore, it was decided that time limit for processing of the consent applications in the purview of HQ should be laid down as under:

- 1) SRO- His office should process application for consent within 30 days time.
- 2) If he has not processed the application under the purview of HQ within 30 days time, the same will have to be transferred and taken up to the office of RO as it is.
- 3) After 30 days the RO should process positively said application within 30 days time, i.e. he should process the said application within 60 days from the original receipt of the said application by SRO/MPCB.
- 4) After 30 days from the receipt of application from SRO, if RO has not completed processing the said application, it shall be transferred to HOD as it is for further processing.
- 5) HOD should process the said application without fail within 30 days from the receipt thereof, provided that after expiry of 30 days, the application shall be kept as it is before the Competent Authority (MS, CC, Chairman & CAC) for taking further necessary decision.

Because of want of time PART-II agenda items placed before the CAC could not be discussed, it was decided that PART-II agenda items can be considered in the next CAC meeting dated 26.09.2012.

The meeting ended with vote of thanks to the Chair.
