While recommending, SRO raised the issue of applicability of RRZ Policy 2009. The application was placed before CAC dated 08.01.2014 &amp; 15.04.2014 and it was decided to refer the case to RRZ Committee due to applicability of RRZ Policy 2009. Accordingly, the matter was referred to said committee. The case was placed before RRZ Committee meeting held on 19.04.2014. The Committee has called the information from MIDC &amp; MPCB.</p> <p>In mean time, industry has submitted the river distance certificate from Executive Engineer, Irrigation Department dated 05.04.2014. The Executive Engineer certified crow fly distance from HFL of Bhama River to their ETP as 1978 mtrs. However, the said certificate was not in the prescribed format.</p> <p>Regional Officer, Pune informed vide letter dated 19.09.2014 that the industry has submitted the revised distance certificate from the Executive Engineer, Irrigation Department dated 10.07.2014. The Executive Engineer certified crow fly distance from HFL of Bhima River to their operational shed is 2019 mtrs.</p> <p>Further, Regional Officer, Pune clarified that the map submitted by the industry certified by Executive Engineer Bhama Askhed Dam Division, the location of the production Hall/ware house area, ETP &amp; STP is 1.69 Km, 1.74 Km &amp; 1.72 Km from nearest edge of River Bhama. The distance measured on the basis of scale mentioned in the map.</p> <p>Hence, the application for 1<sup>st</sup> consent to operate could not be condiseder due to applicability of RRZ and application was kept pending.</p> <p>Environment Department, GoM, vide</p>
