2. Committee observed that the compliance time recommended by HOD is in months, which does not clarify whether it is from the date of meeting or date of issuance of consent. Hence it was decided that general circular shall be issued by AST that the time period for compliance will be recommended with specific date such as 6 months from today-31.06.2013, 4 months from today-30.04.2013, etc.
3. In continuation to the general point number 1 of minutes of CAC meeting held on 24.12.2012, agendas to be placed before CAC meeting shall also include draft of SCN for refusal for the cases where it is recommended to issue SCN for refusal.
4. Regarding circular for validity of consent to establish for a period upto commissioning of unit or 5 years whichever is earlier the validity shall be considered from the date of consent issued such as date of consent- 05.01.2013 maximum validity for C to E- 05.01.2018. In case of Amendment in C to E, 5 years period shall be calculated from the date of original consent and not from the date of amendment issued.
5. Sr. Law Officer shall examine the issue whether demolition is covered in "effective steps" under provisions of EIA notification, 2006.
