1	Direction u/s 5 of the Environment (Protection) Act 1986 in case of m/s Jai Bhavani SSK Ltd., Shivaji Nagar, Georai, Beed	_____	_____	SLO	CPCB has issued direction u/s 5 of the Environment (Protection) Act, 1986 to M/s Jai Bhavani SSK Ltd vide letter dated 18/2/2015. In response to the said direction, the Sub Regional Officer, Aurangabad had reported present status stating the various non compliance that the industry has not in operation in last two seasons and not provided flow meters at inlet and outlet of ETP. The Industry has provided only O & G chamber, Clarifier, anaerobic lagoons two nos and no mechanical part are operative. The JVS results shows higher value of pH, COD ,BOD, SS, TDS and O & G compare to the consented limits. The Industry has not provided close drainage for carrying effluent to the ETP and no separate primary ETP for treatment of effluent from DM plant and boiler Godown. The industry has provide 15 days storage tank for storage of treated effluent and has not stabilized /commissioned ETP before starting crushing season. The industry was in operation for 138 days in the year 2014-2015 and crushing has been done to the tune of 281101 tones of sugar cane.

					<p>The Board had issued show cause notice vide letter dated 27/1/2015 for refusal of renewal of consent in respect of non-compliance of up-gradation of ETP/APC system. The industry has not replied to the said show cause notice till date. Therefore proposal was again kept before Consent Appraisal Committee on 10/4/2015.</p> <p>After due deliberations, it has been decided to refuse consent as well as to issue Proposed Direction directing the industry to show cause as to why industry shall not be closed down on the ground of aforesaid non compliances?</p>

Note:

General Points:

1. The consents shall be disposed after obtaining requisite consent fees as per GoM, revised fee structure dtd. 25.08.2011 and according to the industry wise new validity period. The balance fees on the part of MPCB, if any, shall be considered at the time of next renewal of consent, which shall be mentioned in the consents to be issued hereafter.
2. In case of total construction is exceeding 20,000 sq. mt. built up area, and then no effective steps shall be taken till Environmental Clearance is obtained.
3. RO(HQ) to ensure adequacy of adequate land regarding disposal of treated effluent in non municipal corporation area while granting consent to 1st Operate, necessary condition may also be imposed during grant of C to E.
4. All consent draft with respect to HCE shall be rectified for disposal of ash, disposal of sludge, APC for stacks & draft consent should be revised for combine consent to operate & BMW authorization.
