### **MINUTES OF TEBLE ITEM REGARDING EXCESS CRUSHING CARRIED OUT BY SUGAR INDUSTRIES.**

As per the EIA Notification dtd. 14.09.2006 Environmental Clearance is mandatory for the sugar industries having crushing capacity 5000 TCD & above (5(j)).

The CAC Cell is in receipt of 10 nos. of Consent applications for grant of Renewal of Consent to Operate pertaining to Kolhapur Region. In respect of these applications SRO Kolhapur has reported that there are 6 nos. of sugar units whose crushing capacity is below 5000 TCD which does not attract Environmental Clearance, but these units had carried out excess crushing above 5000 TCD without obtaining Environmental Clearance and Consent to Operate. Remaining 4 nos. of sugar units which are having basic Environmental Clearance but carried out excess crushing more than the threshold limit of Environmental Clearance as well as Consented capacity. The details are as under;

**A) Out of these 10 nos. of sugar industries 4 nos. of industries do not have basic Environment Clearance i.e. crushing capacity below 5000 TCD even though carried out excess crushing above 5000 TCD.**

It is noted that issue regarding excess crushing was discussed in the CAC meeting held on 16.09.2016, during meeting it was decided that in the case of excess crushing (more than 5000 TCD) then the case shall be referred to Environment Dept. / MoEF for EC violation. Similarly if the industry carried out excess crushing but below 5000 TCD then Consent shall be issued by forfeiture of BG and obtaining /imposing condition of BR for excess crushing & top-up BG for not to do excess crushing. Also issue directions regarding excess crushing.

Accordingly, Board has requested to Environment Department, GoM to give opinion in this matter Env. Department, GoM vide letter dtd. 15.12.2016 has given opinion on the issue of excess crushing. Brief of the said letter is as under –

1. Those sugar units which have been accorded Environmental Clearance as per the EIA Notification 2006, and out of these sugar units those which have crossed the threshold limit as against accorded in EC credible action shall be initiated against such sugar units under the provisions of E(P) Act, 1986 as per the Office Memorandum issued by MoEF vide dtd. 12.12.2012.
2. Those sugar units which have been not accorded Environmental Clearance as per the EIA Notification 2006 but carried out excess crushing more than 5000 TCD, in such cases credible action shall be initiated against such sugar units under the provisions of E(P) Act, 1986.
3. Considering above points MPCB should ensure before granting Consents to these sugar units that the pollution load of these units should be less than the pollution load stipulated in Environmental Clearance.

In view of above it was decided to consider the above cases for grant of Renewal of Consent to Operate by imposing following conditions –

1. Credible actions shall be initiated against above units and after confirming credible action, Renewal of Consent to Operate shall be granted by imposing Board Resolution.
2. Crushing capacity shall be restricted to the threshold limit as prescribed in EC and Consent.
3. Industry should not exceed the threshold limit of overall pollution load accorded in Environmental Clearance and Consent granted by the Board.
4. The Sugar plant having basic EC but crossed threshold consented and EC limit, existing BG shall be forfeited and impose fresh BG of Rs. 25 lacks towards not to carry out excess crushing in future alongwith affidavit regarding same.
5. The Sugar plant not having basic EC but crossed threshold consented and EC limit of 5000 TCD and above, existing BG shall be forfeited and impose fresh BG of Rs. 50 lacks towards not to carry out excess crushing in future alongwith affidavit regarding same.
6. Consent shall be issued after submission of above mentioned BGs.
7. RO shall strictly monitor above units on weekly basis and submit compliance report to CAC CELL including source and ambient air quality monitoring reports.

Similarly in the case of distillery unit of M/s. Shree Chhatrapati Sahu SSK Ltd., Kagale, Tal. Kagal, Dist. Kolhapur it was decided to consider the case for grant of Renewal of Consent to Operate and to issue Restart Directions on the basis of above grounds considered for sugar industries by imposing following conditions –

1. Credible action shall be initiated against the said unit and after confirming credible action, Renewal of Consent to Operate shall be granted by imposing Board Resolution.
2. Production capacity shall be restricted to the threshold limit as prescribed in EC and Consent.

3. Industry should not exceed the threshold limit of overall pollution load accorded in Environmental Clearance and Consent granted by the Board.
4. Existing BG shall be forfeited and impose fresh BG of Rs. 25 lacks towards not to carry out excess production in future alongwith affidavit regarding same.
5. Consent shall be issued after submission of above mentioned BG.

General Item:-

Committee noted that MoEF & CC in the recent notification dated 23.11.2016 has prescribed procedure for certification about “NO INCREASE IN POLLUTION LOAD” for getting exemption from going through the entire EIA process, for change in product mix. Therefore, it was decided to return all the application in CAC in respect of product mix with the approval of Member Secretary and inform the industry that the amendment in change in product-mix will not be considered till the procedure for approval of change in product-mix cases is defined by the Board. Such cases shall not be place before CAC till the procedure for approval of change in product-mix cases is defined by the Board.
