1	List of 38 Hospitals is enclosed as below	Not approved	--	<p>We are covering Health Care Establishments (HCEs) in consent management as per CPCB direction dt 4.6.2012.</p> <p>It is noted that in many of the applications of Health Care Establishments (HCEs), applicant as well as SROs have not mentioned the status of main aspects such as applicability and status of Environmental Clearance, status of STP, ETP and OWC etc. As per EIA Notification dtd. 07<sup>th</sup> July, 2004 and EIA Notification dtd. 14<sup>th</sup> September, 2006 as amended, new construction projects of Hospitals requires prior EC from Competent Authority.</p> <p>In view of above, it was decided to defer the all 38 applications of HCEs received for grant of Combined Consent and BMW Authorization (CCA) and revert back to CAC after receipt of the latest compliance and status report from concern RO/SRO. Concern RO/SRO shall personally cause visit to the HCEs and submit the report within 10 days to CAC.</p>
