## CIRCULAR

**Sub : Invitation of Nominations from SRO and FO/JSO of MPCB for deputation on UNIDO Project entitled "Environmentally Sound Management of Medical Waste in India (Maharashtra)".**

The State of Maharashtra has confirmed its participation in the GEF-UNIDO funded MoEF Project titled "Environmentally Sound Management of Medical Waste in India (Maharashtra)" with an aim to reduce and ultimately eliminate the Persistent Organic Pollutants (Dioxin and Furans) and also to reduce associated pollution problems of Air, Water, Soil and Sediments by ensuring Environmental Sound Management and Handling Systems for Bio-medical Waste.

To implement the said project, Maharashtra Pollution Control Board (MPCB) is a Nodal agency. MPCB has constituted a State Project Management Unit (SPMU) under the Chairmanship of Member Secretary, MPCB. Also, State Project Steering Committee (SPSC), the Committee under the Chairmanship of Principal Secretary, Dept. of Env., GoM will supervise implementation of the project.

In this regard, Board intends to form a Special Cell for GEF-UNIDO Project Head Quartered at Nirmal Bhavan, Mahape, Navi Mumbai. A brief scope of the project is as below :

1. Assessment of Health Care Establishments for Bio-Medical Waste Generation, Management and Handling.
2. To impart awareness and training of best practices in collection, segregation, storage, transportation of BMW to stake holders.
3. Identification of suitable techniques / technologies for effective management and handling of BMW.
4. Implementation of non-burn technologies (NBT) for BMW treatment and disposal.
5. To develop Nashik as model district in respect of BMW implementation

Board intend to invite applications / willingness of Sub Regional Officers and Field Officers / Junior Scientific Officers. SRO will be In-charge of the Special Cell, assisted by 3 FOs / JSOs of the Board. The appointment of all the officers deputed in the Special Cell shall be initially for one year, extendable for another two years based on their annual performance.

They will be eligible for deputation allowance and project specific perks as per admissibility. They will be supported by necessary office infrastructure including Vehicle and Driver.

Those who are interested shall submit their application directly through e-mail to the Member Secretary, MPCB, with a copy to Principal Scientific Officer and Accounts Officer (EB) with their latest bio-data, for further consideration.

The application complete in all respect should be submitted on or before 10<sup>th</sup> November, 2014.
