Circular – Amendment

Sub: 'Central Inspection System(CIS) & Randomized Risk Based Inspection & Sampling' procedure through software based tool for Officers of the Board and uploading visit report on web portal

Ref: 1.Board's Circular No.MPCB/AST/TB-3651 dated 11/09/2017
2. Constitution of Central Inspection System vide GR dated 29/8/2017 issued by Labour Department, Government of Maharashtra.

Maharashtra Pollution Control Board is functioning under the Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention and Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986. Board has powers of **Entry and Inspection of the establishments** u/s 23 (1) of Water (Prevention & Control of Pollution) Act, 1974, u/s 24 (1) of Air (Prevention & Control of Pollution) Act, 1981 and u/s 10 (1) Environment (Protection) Act, 1986.

Board has introduced "Randomized Risk Based Inspection & Sampling" through CIS (software based tool) for selection of industries based on pollution potential. This software based tool for field staff is introduced to ensure the transparency and strong monitoring mechanism of the Field Officers performance. The list of the industries for sampling and inspection for each Field Officer is generated for his jurisdiction through software and same is monitored through automated software based tool.

Amendment: Board has made provision for establishments to download their past two year's Inspection Reports. The establishments can view their past two year's Inspection Reports through Board's ec-MPCB portal available on Board's website.

All Regional / Sub-Regional Officers to ensure that past two years (i.e. from January'2015) Inspection Reports are made available on ec-MPCB portal.

This Circular is amendment to the above referred Ref:1 Circular and will come in force with immediate effect.
