OFFICE ORDER No. - 174 OF 2015

Sub: Constitution of Committee for scrutiny of authorizations for all Corporations/Councils as per the Municipal Solid Waste (M&H) Rules, 2000.

In suppression of order at reference 2,3 & 4 as above, the revised order is as follows:

The Municipal Solid Waste (Management & Handling) Rules were notified by the MoEF in September, 2000, making it mandatory for urban local bodies to improve their waste management system as envisaged. Though municipal solid waste management is an essential and obligatory function of the urban local bodies, service level has fall short of desired level.

There are 26 Municipal Corporations and 231 Municipal Councils and Cantonment Boards/Nagar Panchayat generating around 20,000 MT/day of Municipal Solid Waste in Maharashtra State. In order to comply the rules effectively and to have a proper monitoring mechanism, it is proposed to constitute a Committee for implementation of MSW (M&H) Rules, 2000.

The Board receives applications for authorization from various local bodies and the same has to be scrutinized, processed for grant of authorization. The Board has now decided in the Consent Appraisal Committee meeting held on 04.12.2013 **to constitute a committee for scrutiny of the application for authorization of municipal corporations/councils and to make suitable recommendation to Consent Committee.** Following committee is hereby constituted for effective implementation of MSW (M&H) Rules, 2000.



Terms of reference of the committee are as under:

- 1) To examine / scrutinize applications for grant / renewal of authorization under MSW (M&H) Rules, 2000, of the Municipal Corporation/Municipal Councils and to place before the Consent Committee.
 - a) To examine the technology adopted/to be adopted.
 - b) To examine adequacy of availability of land.
 - c) To inspect the site if required.
- 2) To evaluate various processing technologies in vogue, emerging processing technologies and make suitable recommendations.
- 3) Preparation of Status Reports of all Municipal Corporation and 'A' Class Municipal Councils reg. MSW Rules.
- 4) To suggest for improvement in existing MSW facilities of the ULB's.
- 5) Preparation of model/pilot project for ULB's.
- 6) Any other references as per the Consent Committee or by the Member Secretary.

The committee shall meet once in three months or as and when required.

The committee member will be remunerated the meeting charges and visit charges if any as per extant Board policy.
