## OFFICE ORDER

Sub : Constitution of Sub-Group for dealing with slaughter houses,  
bone mills and other animal/product processing covering under  
Consent Regime and application of standards.

Ref : Minutes of the Consent Committee Meeting held on 27/6/2014.


It has been decided to formulate a Sub-Group under the Chairmanship of the Principal Scientific Officer, MPCB, so as to give suitable Policy Recommendations and General Guidelines for various environmental issues related to slaughter houses/bone mills/animal products etc. Accordingly, the following Sub-Group is formed.

1. The Sub-Group will decide Locational Criteria for slaughter houses etc. in Municipal and Non-Municipal areas.
2. The Sub-Group will decide about the suitable safeguards and stringent disposal standards for slaughter houses etc. in Municipal areas.
3. The Sub-Group will suggest a suitable strategy for effective operations of slaughter houses owned by the Municipal Bodies.
4. Any other recommendations.

The Sub-Group will give its report on or before 15<sup>th</sup> September, 2014 for taking decision about grant of consent.
