premise.
9. Industry should prepare an environment management plan
for the construction as well as operation phase and the
same shall be shared with the board.
10. As per CPCB guidelines, industry shall install OCEMS for
effluent/air emissions with connectivity to Board's Server.
11. Industry shall make provision of necessary air pollution
arrangements to control fugitive emissions/nuisance of
Ammonia smell and Alarm system for alerting towards
leakage of gases including Ammonia.
12. Industry shall observe stringent stack emission standards
for parameter NO ₂ < 220 mg/Nm ³ for Primary Reformer

13. Industry has proposed to vent CO ₂ . However, industry shall

Industry shall ensure that there is no organic pollutant in the

14. As proposed, the product Ammonia shall be transferred
through pipeline to the sister concern unit and no Ammonia
storage facility will at site except two tanks of capacity
5,000T & 20,000T for emergency storage. The storage shall
be cryogenic, in double walled, double containment tanks
with best in class mitigation measures with multiple
redundancies to prevent any accidental NH3 release and
mitigate the effects of any process disturbances, valve
failures, power outages. The design should be robust
