- 3. Circular about when to make Ozonisation technology compulsory, instead of chlorination to be put up by JD(APC).
- 4. Note on effluent standards to be prescribed for Hotel activities shall be put up by AST. (w.r.t. to the Hyatt Regency Consent)
- 5. Note on effluent/emission standards to be prescribed for Nuclear Power Plant shall be put up by PSO. The JD(APC) shall review all nuclear Power Plant consent, which are complying & not complying with disposal standards based upon the note.
