- i. Review of Bank Guarantee release/renewal/forfeiture.
- ii. Imposing fresh Bank Guarantee as top-up in case of forfeiture.
- iii. Minor amendment in consent, excluding change in production.
- iv. Increase in Capital Investment above 10% etc.

The decision taken by the sub-committee in such cases shall be confirmed in the CAC / CC respectively in its ensuing meeting.

Because of want of time Part-I I (Agenda Item No. 23 to 42) & Part-III agenda items placed before the CAC could not be discussed, it was decided that the same agenda items can be considered in the next CAC meeting dated 19.03.2013.
