Further, CAC discussed on following points;

- 1. It was decided that AS(T) should issue circular regarding uniform validity of consent period depending on type of industries.
- 2. CAC noted that summary sheets submitted with agenda by the HODs are not in proper format and with incomplete information. Hence it is instructed that proper format and information should be submitted.
- 3. The issue in respect of establishment and operation of two different industries under Red and Green Category activities under same group of Avanta Companies, but having different management came up for consideration of CAC. After due deliberations, it was decided that the

issue in respect of Amalgamation of two different categories of the activities under the same management or different management with Joint Pollution Control Devices shall be examined by P & L Division along with JD (APC) and put up in the next CAC.

Because of want of time review items placed before the CAC could not be discussed, it was decided that the same agenda items can be considered in the next CAC meeting dated 22.03.2013.
