General Points:

 Circular/guidelines to be issued to all SRO/ RO that if the distance of nearest notified river is more than 5 Km then there is no need of distance certificate. Also the distanced mentioned by SRO in processing sheet should be justified alongwith the methodology used for mentioning the same.
