JD(WPC) to issue circular with reference to Phase wise construction carried out by project proponent and consideration of the capital investment as per the Board circular and in case of infrastructure project the CI shall be considered as per the EC.

The covid period from 1<sup>st</sup> April 2020 to 31<sup>st</sup> October 2021 shall be considered for exemption of penal fees, to the projects which has failed to apply and obtained the consent.
