Thereafter, CAC discussed the following points;

- It was found that statement of JVS analysis results of the industry are placed before CAC
 in different formats without standard and sometimes results are too old. Hence, it was
 decided that statement of JVS analysis results of all CAC cases shall be placed in
 uniform format. A circular shall be issued by AS(T).
- CAC pointed that the compliance report of industries are not being submitted by RO/SRO to MPCB(HQ) in-spite of several reminders. A circular in this respect shall be issued to RO/SRO to submit the same within 8 days without fail.
- 3. The industry-wise (such as power plant, cement, chemical, etc.) review w.r.t. JVS results, stack monitoring, H.W., standards, required guidelines, treatment provided, etc. shall be done in CAC.
