Talegaon. Hence does not fulfil the coverage area criteria of 75 km
as per CPCB guidelines dtd 21/12/2016.
PP has submitted the gap assessment and projection of BMW for
2030 for Pune District on 22/07/2022. The Report is authenticated
by Civil Surgeon and DHO, ZP Pune.
The submitted project report is shows projection for 2030 on the
basis of 3 different growth rate scenarios1) Economic growth rate
of Maharashtra (12.1% growth rate) 2) BMW generation potential
based on positive growth of BMW generation in Gujrat (13.27%
growth rate) 3) BMWgeneration potential based on positive
growth of BMW generation in Gujrat (15.33% growth rate).
The economic growth rate of Maharashtra scenario is considered
as other two scenario are based on the BMW generation in Gujrat.
For preparation of projection PP has considered the BMW
generation 0.20 Kg /bed/day, 0.22 Kg/bed/day, and
0.28Kg/bed/day and economic growth rate of Maharashtra 12.1%,
projected BMW generation for year 2030 is 0.931 MT/day, 3.85
MT/day, and 2.61 MT/day respectively. In accordance with this
calculation PP has projected the BMW generation in Year 2030 is
from 1 MT/day to 3.8MT/day.
The M/s Passco Environmental Solution, Pune & M/s Passco
Environmental Solution, PCMC obtained C to E and EC for
expansion of BMW CTF for incineration capacity of 10.80 MT
each(Total 21.60 MT/day) . Expansion of Passco Environmental
solution, Pune is completed and Expansion of PCMC is expected
within a one year.
At present Pune district have incinerator capacity 6.76 MT / day
to treat the incinerable BMW however after expansion it will be
24.66 MT/day as against projected BMW generation in 2030 is

						 29.19 MT/day to 40 MT/day. The existing facility are capable to treat the present generation of BMW. As per BMW annual report the BMW generated by Bedded HCE in year 2016 - 0.23 Kg/Bed/day, 2017 - 0.17 Kg/bed/day, 2018 - 0.17 Kg/bed/day 2019 - 0.17 Kg/bed/day, 2020 - 0.21 Kg/bed/day (Covid Period).
