## CIRCULAR

Sub : Attendance of courts for evidence by retired officers of the MPCB.

Ref : Letter received from Shri R.G.Pethe, Ex-Water Pollution Abatement Engineer, Ex-WPAE, dtd.19/11/2009.

The Regional Officers and Sub-Regional Officers of the Maharashtra Pollution Control Board have filed various court cases before the Hon'ble JMFC, CJM Courts in various Districts of Maharashtra against the defaulting industries/local bodies. In this regard, the Retired officers of the Maharashtra Pollution Control Board are required to attend various Courts for recording their evidence before and after framing of the charges.

Shri R.G. Pethe, Ex-WPAE vide letter dtd.19/11/2009 communicated that it is necessary to provide traveling and staying arrangements, allowance for briefing the Advocates and for attending various courts for recording evidence till their chief and cross completed. He has therefore requested to pay necessary allowances with to & fro journey and other incidental expenditure on transport, stay etc.

The said matter was put up before the Authorities, wherein, it was decided to sanction TA/DA as per the cadre of the retired officers at the time of retirement, who are attending the respective courts. The TA/DA Bills of the Retired officers should be certified by the respective Regional Officers / Sub-Regional Officers / Law Officers to sanction their claim and the Accounts Branch / respective Regional Officers should make their payment out of their Imprest Account for Legal Expenditure Head.
