This is existing industry, applied for renewal of consent for mfg of Molded Rubber Sheets with change in categorization from ORANGE category to GREEN category by referring categorization published by CPCB in the year 2016.</p> <p>2. Raw material involved are - Natural Rubber (Natural or Latex), Ethylene Propylene Diene Monomer Rubber (EPDM, Nitrile Rubber, Butyl Rubber, Neoprene Rubber, Reclaim Rubber, Resins, Additives & Carbon in mfg process.</p> <p>3. Mfg process involves- Mixing + Calendaring + Vulcanising + finishing activity.</p> <p>4. Industry has provided Baby Boiler for which fuel required is Briquettes- 14 T/Month & provided Cyclone dust collector.</p> <p>5. Industry has stated that, by following method of calculating pollution index their unit scored less than 25 and hence it is to be categorized under GREEN category. Further industry has also stated that, they are manufacturing rubber goods by molding process and not manufacturing synthetic rubber.</p> <p>6. Decision on category: It was decided to Categorize this activity, in to Existing Orange Category at 76 (original Sr.no.79) as per CPCB industry categorization dt: 07/03/2016, for mfg. Synthetic rubber, since industry is using raw material which are synthetic in nature.</p>

Manufacturing process involves coating of water-based chemicals on fabric & leather.</p> <p>3. Raw material involved are - Fabric, Polyurethane Chemicals, Leather Crust & packaging materials.</p> <p>4. Domestic effluent- 8.0 CMD, Industrial effluent :- 4 CMD & treated effluent will be disposed on land for gardening /irrigation.</p> <p>5. HW generation will be in the form of ETP sludge (HW Cat 35.3)-100 kg/month same will be disposed to CHWTSDF.</p> <p>6. As industry will be processing leather crust using chemicals and daily production will be more than 1.2 MT (Synthetic Textile/Finished leather) also there will be water score (more than 10), air score (About 10) and HW score.</p> <p>7. <u>Decision on category:</u> It was decided to categorize this manufacturing activity in to the <u>Existing Red Category</u> (at Sr. no. 40 at <u>Original sr.no. 84</u>) as per <u>CPCB industry categorization dt: 07/03/2016.</u></p>
