## Amendment in Consent to operate conditions of Coal based Thermal Power Plant

**Sub: Amendment in Consent to Operate by incorporation of condition of use of coal having ash contain less than 34%.**

Ref: 1] Consent to operate granted by the Board.

2] MOEF Notification bearing no.02 (E), G.S.R.dated 02.01.2014.

3] MOEF office Memorandum dated 26.08.2015.

In partial modification in the Consent to operate issued by the Board. The following amendment by addition of conditions are made.

**READ:**

**General Conditions;**

1. Coal based thermal power plant shall comply MOEF Notification dated 02.01.2014 by supplied with and shall use, raw or blended or beneficiated coal with ash content not exceeding 34% on quarterly average basis.
2. Coal based thermal power plant shall comply MOEF office memorandum dated 26.08.2015 by protocol for sampling, analysis of coal and reporting of compliance in respect of implementation of the Gazette Notification on use & supply of raw or blended or beneficiated coal with ash content not exceeding 34% on quarterly average basis.

3. Coal based thermal power plant shall comply MOEF Notification dated 07.12.2015 with respect to standards stipulated in the Notification as per the time schedule.
4. Coal based thermal power plant shall comply consent conditions; conditions stipulated in the Environmental Clearance.
5. Coal based thermal power plant shall comply with the fly ash Notification dated 03.11.2009 and Amended in 25.01.2016.

All the other conditions of the Consent issued by the Board to operate the coal based thermal power plants remain unchanged. This amendment is valid only along with the valid Consent issued by the Board.
