

AND WHEREAS the Board vide letter cited at ref. (3) has issued SCN for refusal for non compliance of consent conditions & conditional restart directions issued by Board vide letter dtd 23/12/2011.

The application was discussed in Consent Appraisal Committee meeting held on 02.03.2012 and it was decided to issue refusal of renewal of consent due to non-submission of BG as per directions issued by the Board and for not completing the work of compost yard, etc.
