Sub: Refusal of Consent under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules 2008.

WHEREAS, Board has granted Consent to Establish under Section 25 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management Handling & Transboundary Movement) Rules, 2008 to your unit stipulating conditions to be adhered to by the industry.

AND WHEREAS, you have applied for first Consent to operate under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management Handling & Transboundary Movement) Rules, 2008.

AND WHEREAS Regional Officer, MPCB, Nagpur vide letter dated 24.1.2012 reported the. you have not provided the secondary emission control system to the existing unit and the analysis report of stack monitoring of existing unit are exceeding the standards prescribed in the consent.

AND WHEREAS , Board had issued show cause notice vide letter under reference 3 due to non compliance of consent conditions. AND WHEREAS, the reply of SCN submitted by you vide letter dated 26.3.2012 is unsatisfactory.

AND WHEREAS, you have not complied with the consent to establish conditions, which shows your negligent attitude towards the Environment protection laws.

AND WHEREAS, you have violated the Water (Prevention and Control of Pollution) Act, 1974. & Air (Prevention and Control of Pollution) Act, 1981.

AND WHEREAS your case for first consent to operate has been discussed in Consent Appraisal Committee Meeting of the Board held on 16.4.2012 and it was decided to refuse the consent to 1st operate due to the non-compliance of conditions stipulated in consent to Establish.

In view of the above, your application for first consent to operate of reduced briquette Sponge iron -200 TPD plant is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.
