3. CONDITIONS UNDER WATER ACT:

- : The daily quantity of trade effluent from the factory shall be NIL.
- the The daily quantity of sewage effluent from the factory shall not exceed 2.5 M3.

Sewage Effluent Treatment: The applicant shall provide comprehensive treatment system as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards.

(1) Suspended Solids Not to exceed 100° mg/l. (2) BOD 3 days 270 C. Not to exceed 100° mg/l.

(vi) Sewage Effluent Disposal: The treated domestic effluent shall be soaked in a soak pit, which shall be got cleaned periodically. Overflow, if any, shall be used on land for gardening plantation only.

4. The applicant shall comply with the provisions of the Water (Prevention & Control of Pollution) Cess Act, 1977 (to be referred as Cess Act) and amendment Rules, 2003 there under

The applicant shall regularly submit to the Board the returns of water consumption in the prescribed form and pay the Cess as specified under Section 3 of the said Act.

5. CONDITIONS UNDER AIR ACT:

The applicant shall install a comprehensive control system consisting of control equipments as is warranted with reference to generation of emission and operate and maintain the same continuously so as to achieve the level of pollutants to the following standards:

a. Control Equipment: -

- 1) Fame extraction system followed by Dust collection system of sufficient capacity should be provided to all sources of SPM/TPM shall be operated properly and continuously
- ine. There shall not be any secondary (Fugitive) emissions.

6. Conditions for D.G. Set

Noise from the D.G. Set should be controlled by providing an acoustic enclosure or by treating the room acoustically.

Industry should provide acoustic enclosure for control of noise. The acoustic enclosure acoustic treatment of the room should be designed for minimum: 25 dB (A) insertion loss or for meeting the ambient noise standards, whichever is on higher side. A suitable exhaust muffler with insertion loss of 25 dB (A) shall also be provided. The measurement of insertion loss will be done at different points at 0.5 meters from acoustic enclosure/room and then average.

The industry shall take adequate measures for control of noise levels from its own sources within the premises in respect of noise to less than 75 dB(A) during day time and 70 dB(A) during the night time. Day time is reckoned between 6 a.m. to 10 p.m and night time is reckoned between 10 p.m to 6 a.m.

- d. Industry should make efforts to bring down noise level due to DG set, outside industrial premises, within ambient noise requirements by proper sitting and control measures.
- e. Installation of DG Set must be strictly in compliance with recommendations of DG Set manufacturer.
- f. A proper routine and preventive maintenance procedure for DG set should be set and followed in consultation with the DG manufacturer which would help to prevent noise levels of DG set from deteriorating with use
- 2 D.G. Set shall be operated only in case of power failure
- n. The applicant should not cause any nuisance in the surrounding area due to operation of D.G. Set

Whenever due to any accident or other unforeseen act or even, such emissions eccur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments. the production process connected to it shall be stopped.

8. Industry shall comply with following additional conditions:

The applicant shall maintain good housekeeping and take adequate measures for control of pollution from all sources so as not to cause nuisance to surrounding area

The applicant shall bring minimum 33% of the available open land under green

coverage tree plantation.

Solid waste - The non hazardous solic waste arising in the factory premises. sweepings, etc., be disposed of scientifically so, as not to cause any nuisance pollution. The applicant shall take necessary permissions from civic authorities for disposal to dumping ground.

The applicant shall provide for an alternate electric power source sufficient to perate all pollution control facilities installed by he applicant to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shalf stop, reduce or otherwise, control production to abide by terms & conditions of this consent regarding pollution levels.

The applicant shall not change or alter quantity, quality, the rate of discharge, than erature or the mode of the effluent / emissions or hazardous wastes or control

equipments provided for without previous written permission of the Board.

The applicant shall provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous wastes to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf.

vii. The applicant shall make an application for renewal of the consent at least 60 days

before the date of the expiry of the consent.

.III. The firm shall submit to this office, the 30th day of September every year, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as pre-the provisions of rule 14 of the Environment (Protection) Second Amendment Rules, 1992.

m. As inspection book shall be opened and made available to the Board's officers during that visit to the applicant.
