This office is in receipt of your application for grant of renewal of Consent under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

AND WHEREAS as the Board vide letter cited at ref (5) has issued Show cause notice for refusal of consent as industry were discharging untreated effluent, not confirming to the standards prescribed in the consent order and thereby, causing pollution in the surrounding area at Madhukar Nagar , Patas, Tal.- Daund, Dist. – Pune and causing threat to natural water body of river Bhima and JVS results are exceeding the consented standards and non compliance of the Directions issued by Board.

AND WHEREAS, your application along with your reply to show cause notice was discussed in consent Appraisal committee meeting held on 29.05.2012 and It was decided to refuse the consent as industry has not complied to the Directions issued by the Board. And also it was decided that Industry shall comply directions issued by Board and then apply for fresh Renewal of Consent.

In view of above, your application for grant of renewal of Consent to operate is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.
