located in the area declared under the provisions of the Water Act, Air act and Authorization under the provisions of HW(M, H &TM) Rules and amendments thereto subject to the provisions of the Act and the Rules and the Orders that may be made further and subject to the following terms and conditions:

1. The Consent to Operate is granted for a period up to: 31.03.2013.

2. The Consent is valid for the manufacture of -

3. CONDITIONS UNDER WATER ACT:

- (i) The daily quantity of trade effluent from the factory shall not exceed 45.00M3.
- (ii) The daily quantity of sewage effluent from the factory shall not exceed 8.00M3.
- (iii) Trade Effluent :

<u>Treatment</u>. The applicant shall provide comprehensive treatment system consisting of primary / secondary and/or tertiary treatment as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of the treated effluent to the following standards:

- (iv) Effluent Disposal: The treated effluent shall be recycled / reused to the maximum extent in the process and rest shall be used for irrigation / gardening only. In no case, at any time effluent shall finds its way to any water body directly or indirectly.
- (v) Sewage Effluent Treatment: The applicant shall provide comprehensive treatment system as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards.

(viii)Other Conditions: Industry should monitor effluent quality regularly.

4. The applicant shall comply with the provisions of the Water (Prevention & Control of Pollution) Cess Act, 1977 (to be referred as Cess Act) and amendment Rules, 2003 there under

The daily water consumption for the following categories is as under:

(i) Domestic purpose ... 10.00CMD
(ii) Water gets Polluted & 20.00CMD
(iii) Water gets Polluted, Pollutants are not Biodegradable & Toxic ... 0.00CMD
(iv) Industrial Cooling, spraying in mine pits or boiler feed 660.00CMD

The applicant shall regularly submit to the Board the returns of water consumption in the prescribed form and pay the Cess as specified under Section 3 of the said Act.

5. CONDITIONS UNDER AIR ACT:

(i) The applicant shall install a comprehensive control system consisting of control equipments as is warranted with reference to generation of emission and operate and maintain the same continuously so as to achieve the level of pollutants to the following standards:

1. Control Equipment:

Electrostatic precipitator of adequate capacity shall be provided to bagasse fired boiler to limit the air emissions.

2. Standards for Stack Emissions:

- (iv) The applicant shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted/ displayed to facilitate identification.
- (v) The industry shall take adequate measures for control of noise levels from its own sources within the premises so as to maintain ambient air quality standard in respect of noise to less than 75 dB(A) during day time and 70 dB(A) during night time. Day time is reckoned in between 6 a.m. and 10 p.m. and night time is reckoned between 10 p.m. and 6 a.m.
- (vi) Other Conditions:
 - 1) The industry should not cause any nuisance in surrounding area.
 - The industry should monitor stack emissions and ambient air quality regularly.

6. Conditions for D.G. Set

- a. Noise from the D.G. Set should be controlled by providing an acoustic enclosure or by treating the room acoustically.
- b. Industry should provide acoustic enclosure for control of noise. The acoustic enclosure/ acoustic treatment of the room should be designed for minimum 25 dB (A) insertion loss or for meeting the ambient noise standards, whichever is on higher side. A suitable exhaust muffler with insertion loss of 25 dB (A) shall also be provided. The measurement of insertion loss will be done at different points at 0.5 meters from acoustic enclosure/room and then average.
- c. Industry should make efforts to bring down noise level due to DG set, outside industrial premises, within ambient noise requirements by proper sitting and control measures.
- d. Installation of DG Set must be strictly in compliance with recommendations of DG Set manufacturer.
- e. A proper routine and preventive maintenance procedure for DG set should be set and followed in consultation with the DG manufacturer which would

f. D.G. Set shall be operated only in case of power failure

g. The applicant should not cause any nuisance in the surrounding area due to operation of D.G. Set.

7. CONDITIONS UNDER HAZARDOUS WASTE (MANAGEMENT, HANDLING & TRANSBOUNDRY MOVEMENT) RULES, 2008:

(i) The Industry shall handle hazardous wastes as specified below.

(ii) Treatment: -

- 1. The authorization is hereby granted to operate a facility for collection, storage, transport & disposal of hazardous waste.
 - a. Whenever due to any accident or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.
- 8. General Conditions:
 - (i) The applicant should bring minimum 33% of the available open land under green coverage/ plantation. The applicant should submit a yearly statement by 30th September every year on available open plot area, no. of trees surviving as on 1st March of the year and no. of trees planted by September end.
 - (ii) The applicant should provide for an alternate electric power source sufficient to operate all pollution control facilities installed by the applicant and operate the same in case of power failure to maintain compliance with the terms and conditions of the consent. In the absence of same, the applicant should stop, reduce or otherwise, control production to abide by terms & conditions of this consent regarding pollution levels.
 - (iii) The applicant should make an application for renewal of the consent at least 60 days before the date of the expiry of the consent. The applicant should not change or alter quantity, quality, the rate of discharge, temperature or the mode of the effluent/ emissions or hazardous wastes or control equipments provided for without previous written permission of the Board.
 - (iv) The firm should submit MPCB, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as pre the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992 before 30th September every year.
 - (ii) The applicant should install a separate meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment should be maintained. The applicant should also submit a comparative statement of designed power and chemical consumptions vis-a vis actual power and chemical consumption along with Environmental statement.
 - (vi) Separate drainage system should be provided for collection of trade and sewage effluents. Terminal manholes should be provided at the end of collection system with arrangement for measuring the flow. No effluent should be admitted in the pipes/sewers down- stream of the terminal manholes. No effluent should find its way other than in designed and provided collection system. Neither storm water nor discharge from other premises should be allowed to mix with the effluents from the factory.
 - (vii)

The applicant should provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous wastes to the Board staff at the terminal or designated points and should pay to the Board for the services rendered in this behalf. An inspection book should be opened and made available to the Board's officers during their visit to the applicant.

(viii) The industry should ensure that fugitive emissions from the activity are controlled so as to maintain clean and safe environment in and around the factory premises.

- The applicant should maintain good housekeeping and take adequate (ix)measures for control of pollution from all sources so as not to cause nuisance to surrounding area / inhabitants.
- 9. Industry should comply with the Hazardous Waste (Management, Handling & Boundary Movement) Rules, 2008.
- 10. Industry shall comply with the conditions of Environmental Clearance obtained from Environment Department, Govt. of Maharashtra vide letter No. SEAC-2010/CR.234/T.C.2, dt.23.12.2011.
- 11. Industry shall either provide separate Effluent Treatment Plant for the effluent generated from the Co-generation plant within four Months as per Environmental Clearance condition or get amendment in Environmental Clearance from competent authority as per EIA Notification, 2006 and meanwhile effluent shall be treated in exiting ETP of Sugar unit to achieve the standards as per E.P. Act and applicant shall submit the Bank Guarantee of Rs. 5.0 Lakhs towards the compliance of the same. The Bank Guarantee shall be submitted within 15 days at Regional Office Pune
- 12. This Consent is issued pursuant to the decision of the Consent Committee meeting of the Board held on 17.10.2012 and with the approval of Hon'ble Chairman of the Board.
- 13. The Capital investment of the industry is Rs, 99.45 Crores.
