# 5. CONDITIONS UNDER AIR ACT:

(i) The applicant shall install a comprehensive control system consisting of control equipments as is warranted with reference to generation of emission and operate and maintain the same continuously so as to achieve the level of pollutants to the following standards:

### **Control Equipment: NA**

#### Conditions for DG Sets: -

- 1. Noise from DG Sets shall be controlled by providing acoustic enclosure or by treating the room acoustically.
- 2. Applicant should provide acoustic enclosure for control of noise. The acoustic enclosure/acoustic treatment of the room shall be designed for minimum 25 dB (A) insertion loss or for meeting the ambient noise standards, whichever is on higher side. A suitable exhaust muffler with insertion loss of 25 dB(A) shall also be provided. The measurement of insertion loss shall be done at different points at 0.5 meters from acoustic enclosure/room and then average.
- 3. The Applicant should make efforts to bring down noise level due to DG Set, outside the premises, with ambient noise level requirements by proper setting and control measures.
- 4. Installation of DG Set must be strictly in compliance with recommendations of DG set Manufacturer.
- 5. A proper routine and preventive maintenance procedure for DG Set shall be set and

followed in consultation with the DG manufacturers, which would help to prevent noise

levels of DG Sets from deteriorating with use.

- 6 .The DG set shall be operated only in case of power failure. The applicant shall make arrangement for regular electrical power.
- 7. The Applicant shall not cause any nuisance in the surrounding area due to operation of DG sets.
- 8. In case of problems, the D.G. set shall not be operated until it is set back to satisfactory position.

# 7. Industry shall comply with following additional conditions:

- The applicant shall maintain good housekeeping and take adequate measures for control of pollution i. from all sources so as not to cause nuisance to surrounding area / inhabitants.
- ii. The applicant shall bring minimum 33% of the available open land under green coverage/ tree plantation.
- iii. Solid waste The non hazardous solid waste arising in the factory premises, sweepings, etc., be disposed of scientifically so as not to cause any nuisance / pollution. Options for setting up biogas plant for treatment of organic waste arising out of plant as well as colony shall be explored and implemented in phased manner.

- vi. The applicant shall make an application for renewal of the consent at least 60 days before the date of the expiry of the consent.
- vii. The firm shall submit to this office, the 30<sup>th</sup> day of September every year, the Environmental Statement Report for the financial year ending 31<sup>st</sup> March in the prescribed Form-V as pre the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992.

viii. As inspection book shall be opened and made available to the Board's officers during their visit to the applicant.

- ix. Neither storm water nor discharge from other premises shall be allowed to mix with the effluents from the factory.
- 8. Whenever due to any accident or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.
- 9 Adequate safety measure shall be provided to limit the risk zone within the plant boundary, in case of an accident. Leak detection devices shall also be installed at strategic places for early detection and warning.
- 11. The capital investment of the unit is Rs.583.0 /- Crores.
