WHEREAS, it has been observed from the Sub-Regional Officer's report that you have applied for grant of Consent to Operate under Section 25/26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Waste (Management, Handling & transboundary movement) Rules, 2008 for research and development activity related to Pharmaceutical products.

AND WHEREAS, during the scrutiny some discrepancies were observed and as per the decision of Consent Committee meeting held on 11.01.2013, you were called upon for personal hearing before Assistant Secretary (Tech) on 21.03.2013. During the hearing Assistant Secretary has instructed for submission of year-wise increase in Capital Investment, water bills of MIDC, Hazardous Waste manifesto, Environment Statement and clarification about inclusion of additional plot. However you have failed to submit the required information in stipulated time period.

AND WHEREAS, your application was resubmitted to Consent Committee meeting held on 29/4/2013 & it was decided to refuse the renewal of consent due to non-submission of required information.

HENCE, your application for grant of Consent for renewal is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.
