WHEREAS, This Office is in receipt of your application for grant of Consent to 1st Operate (Part) for Redevelopment of Residential Building Project at **CTS No. 1790 to 1811, 1813 & 1815 of Village Chembur, CTS No. 131, 133 to 140 of village Wadhwal, Mumbai** under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008


ANDWHEREAS, you have not installed STP as per condition mentioned in Consent to Establish from the Board and Environmental Clearance granted by Government of India, MoEF vide No.21-681/2007-IA.III Dated 13th June,2008. This shows your negligent attitude towards Environmental aspects

ANDWHEREAS, your application was put up before Consent Committee Meeting of the Board held on 13/6/2013 and it has been decided to issue refusal of Consent to 1st Operate(Part) as Project Proponent has not provided STP as per condition of Consent to Establish and Environmental Clearance.

In view of the aforesaid non compliance, your application for grant of Consent to 1st Operate(Part) is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
