This office is in receipt of your application for grant of consent to establish for proposed expansion under Section 25 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Waste (Management and Handling) Rules, 1989 and Amendment Rules, 2003 to your unit.

It has been observed from the Sub-Regional Officer's report that you have applied for grant of consent to establish for expansion. MoEF has imposed Moratorium for Ratnagiri and Sindhudurg districts for the industries which requires EC vide Office Memorandum dtd 16/08/2010. As per the decision of CC meeting dtd. 13.06.2013 this office has issued show cause notice vide above referred letter no. 2. Your reply to show cause notice is received vide above referred letter no. 3. Your reply to SCN was placed before CC meeting held on 17/08/2013 and it was decided to refuse the consent for proposed expansion activity as industry is located in Ratnagiri district where moratorium is imposed.

In view of this, your application for grant of consent to establish for proposed expansion is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.
