It has been also noticed that you have purposefully dropped proposal of manufacturing of Dimethyl Sulphate, just to avoid Environmental Clearance.

AND WHEREAS, your reply dtd. 6/08/13 to Show cause notice issued by the Board vide letter dtd. 26/07/13 was placed before Consent Committee on 17/08/13. AND, the Consent Committee has decided to issue refusal for grant of Consent to Establish as your reply was not found satisfactory.
