

This office is in receipt of your application for grant of amendment of Consent under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundry Movement) Rules, 2008.

AND WHEREAS the Board vide letter cited at ref. (2) has issued SCN for refusal of consent for not submitting the specification of paper(used beverages cartoons) to be imported and not submitting no increase in Pollution load certificate from reputed institute as to comply to RRZ policy.

AND WHEREAS ,the application was discussed in Consent Committee meeting held on 06.09.13 and the reply submitted by you vide referred letter no 3 was taken on record. It is noted that you have still not submitted no increase in pollution load certificate and therefore it was decided to issue refusal Consent due to non submission of no increase in Pollution load certificate as to comply to RRZ policy.

In view of this, your application for grant of renewal of Consent is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Waste (MH & TM) Rules,2008. And you are directed to not to use any imported /used beverages cartoon.

You may make an appeal within a period of 30 days against refusal order.
