WHEREAS, This Office is in receipt of your application for grant of Consent to Establish for setting up of incineration activity for dead animals and animal waste at **S. No. 9 to 14/2, Plot No. 272 to 275, Keshavnagar, Mundwa, Tal- Haveli, Pune** under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008

ANDWHEREAS, it has been observe that location of the project is in no development zone of Mula-Mutha river, as per River Regulation Zone (RRZ) policy, dtd. 13.7.2009.

AND WHEREAS, The case was discussed in River Regulation Zone (RRZ) Committee Meeting, Govt. of Maharashtra dated 7/6/2013 and 5/9/2013 and it was decided that since project is not satisfying RRZ Policy distance criteria, hence Pune Municipal Corporation was requested to find alternative site for said project and related proposal to be submitted before concern review committee for further necessary action.

ANDWHEREAS, your application was put up before Consent Committee Meeting of the Board held on 21/9/2013 and it has been decided to issue refusal of consent, as proposed project does not satisfy the criteria of the River Regulation Zone(RRZ) Policy, Govt. of Maharashtra dtd. 13/7/2009 and as per the decision taken River Regulation Zone (RRZ) Committee Meeting, Govt. of Maharashtra held on 05/09/2013.

In view of the aforesaid non compliance, your application for grant of Consent to Establish is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
