WHEREAS, Board has granted Consent to Operate to your industry under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management and Handling) Rules, 1989 & Amendment Rules, 2003, stipulating conditions to be adhered to by the industry.

AND WHEREAS you have done the expansion without obtaining consent to Establish from the Board.

AND WHEREAS You have not furnished the details of quantum of spent acid generation, its treatment and disposal arrangement.


AND WHEREAS the analysis results of stack monitoring of the stack attached to Galvanizing Furnace and Pickling process are exceeding the standards. AND WHEREAS you have not given the details of cess paid.

AND WHEREAS this office has issued you show cause notice vide letter referred at ref. no 2 for the non-compliances mentioned therein. AND WHEREAS your reply to the SCN is not satisfactory.

AND WHEREAS your case was discussed in Consent Committee Meeting held on 21.09.2013 and it was decided to issue refusal for renewal of consent, as industry has failed to comply with consent conditions, increase in production quantity and non provision of ARP, and issue closure direction and disconnection of power as per the MPC Board procedure.

AND WHEREAS you have violated the provisions of the under the provisions of the Water (Prevention and Control of Pollution) Act, 1974, & Air (Prevention and Control of Pollution) Act, 1981.

Hence, In view of above non-compliances, your application for renewal of Consent is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act, 1974, & under section 21 of the Air (Prevention and Control of Pollution) Act, 1981.
