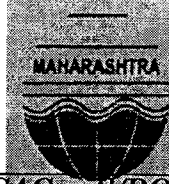

General Conditions:

- 1) The firm shall submit to this office, the 30th day of September every year, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as per the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992.
- 2) An inspection book shall be opened and made available to the Board's officers during their visit to the applicant.
- 3) **The applicant shall make an application for renewal of the consent at least 60 days before the date of the expiry of the consent (in case of Renewal of consent).**
- 4) The applicant shall not change or alter the quantity, quality, the rate of discharge, temperature or the mode of the effluent/emissions or hazardous wastes or control equipments provided for without previous written permission of the Board. The industry will not carry out any activity for which this consent has not been granted/without prior consent of the Board.
- 5) The industry shall submit official e-mail address and any change will be duly informed to the MPCB.
- 6) During transportation handling of Petroleum product if any accident occurs, the industry shall make emergency arrangement and having responsibility to control the situation.
- 7) Industry shall comply with the notification of the manufactures, Storage and Import of Hazardous chemical rule 1989.
- 8) The applicant shall comply with the conditions stipulated in Coastal Regulation Zone Clearance granted by MoEF vide No.11-61/2007-IA.III dated 02.11.2007.
- 9) The smooth & safe operation of the system shall be ensured by incorporating a computerized SCADA (Supervisory Control and Data Acquisition) system. Any leakage in the pipeline shall be immediately detected by the computer system & product pumping shall be immediately cut off.
