WHEREAS, Board has granted Consent to Establish to your 25 MW Power Plant under Section 25 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management and Handling) Rules, 1989, stipulating conditions to be adhered to by the industry.

AND WHEREAS your application for consent to operate for 25 MW Power Plant was discussed in CAC meeting held on 05.10.2013 and it was decided to refuse the consent to operate since Project Proponent has not obtained Environment Clearance as per Consent to Establish condition.

Your application for consent to Operate is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act, 1974, & under section 21 of the Air (Prevention and Control of Pollution) Act, 1981. **You are hereby directed not to take any effective steps towards operation of Power Plant till you obtain the consent to operate from the Board and till you obtain the Environmental Clearance as per EIA Notification 2006 and as amended.**
