We refer to your application as above at Sr. No.1, for grant of Consent u/s 25/26 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management, Handling and Trans - boundary Movement) Rules 2008.

AND WHEREAS, Board office had issued Show Cause Notice for refusal of consent vide letter dated 04/09/2013 and in response to that, the reply submitted by you vide letter dated 07.09.2013, in which besides other points you have stated that the distance from river Panjara / Panjarakan is more than 500 mitr. AND WHEREAS, in consent application the distance is given 900 mtr which is not fulfilling the distance criteria of RRZ Policy 2009. AND WHEREAS, your application was discussed in Consent Committee meeting of the Board held on 15/10/2013 and decided to issue refusal of consent to establish for expansion as the industry is located in No Development Zone of Panzra River i.e. in A-II class of river water.

In view of the aforesaid non compliance, your application for grant of consent to establish for expansion is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
