1. The Consent to Operate is granted for a period up to: 30.06.2017.

2. The Consent is valid for the manufacture of -

- 3. CONDITIONS UNDER WATER ACT:
- (i) The daily quantity of trade effluent from the factory shall be Nil.
- (ii) The daily quantity of sewage effluent from the factory shall not exceed 40 M3.
- (iii) Trade Effluent: N.A.
- (iv) Trade Effluent Disposal: N.A.
- (v) Sewage Effluent Treatment: The applicant shall provide comprehensive treatment system as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards.
 - (1) Suspended Solids Not to exceed 100 mg/l. (2)BOD 3 days 270 C. Not to exceed 100 mg/l.
- (vi) Sewage Effluent Disposal: The treated domestic effluent shall be soaked in a soak pit, which shall be got cleaned periodically. Overflow, if any, shall be used on land for gardening / plantation only.

(viii) Other Conditions: Industry should monitor effluent quality regularly.

4. The applicant shall comply with the provisions of the Water (Prevention & Control of Pollution) Cess Act, 1977 (to be referred as Cess Act) and amendment Rules, 2003 there under

The daily water consumption for the following categories is as under:

(i) Domestic ... 50.0 CMD (ii) Industrial Processing ... 0.0 CMD (iii) Industrial Cooling 250.0 CMI

(iv) Agriculture / Gardening ... 250.0 CMD

The applicant shall regularly submit to the Board the returns of water consumption in the prescribed form and pay the Cess as specified under Section 3 of the said Act.

5. CONDITIONS UNDER AIR ACT:

(i) The applicant shall install a comprehensive control system consisting of control equipments as is warranted with reference to generation of emission and operate and maintain the same continuously so as to achieve the level of pollutants to the following standards:

A) Control Equipment:

- 1. Fume extraction system followed by dust collection system of sufficient capacity shall be provided at all dust generating locations and operated properly and continuously.
- 2. Adequate cyclone followed by bag house filter/ Wet scrubber of sufficent capacity shall be provided to the induction furnace and operated properly and continuously.
- 3. Industry to provide secondary emission control system for emission occurs during the process of loading of raw material as well as unloading the product, i.e. While powering the molten metal.
- 4. There shall not be any secondary (fugitive) emissions.

B) Standards for Emissions of Air Pollutants:

(i) SPM/TPM Not to exceed 150 mg/Nm³
(ii) SO₂ Not to exceed 1.64 Kg/Hrs

C) The applicant shall observe the following fuel pattern:

D) The applicant shall erect the chimney(s) of the following specifications:-

E) Conditions for D.G. Set

- i. Noise from the D.G. Set should be controlled by providing an acoustic enclosure or by treating the room acoustically.
- ii. Industry should provide acoustic enclosure for control of noise. The acoustic enclosure/ acoustic treatment of the room should be designed for minimum 25 dB (A) insertion loss or for meeting the ambient noise standards, whichever is on higher side. A suitable exhaust muffler with insertion loss of 25 dB (A) shall also be provided. The measurement of insertion loss will be done at different points at 0.5 meters from acoustic enclosure/room and then average.
- iii. Industry should make efforts to bring down noise level due to DG set, outside industrial premises, within ambient noise requirements by proper sitting and control measures.
- iv. Installation of DG Set must be strictly in compliance with recommendations of DG Set manufacturer.
- v. A proper routine and preventive maintenance procedure for DG set should be set and followed in consultation with the DG manufacturer which would help to prevent noise levels of DG set from deteriorating with use
- vi. D.G. Set shall be operated only in case of power failure.
- vii. The applicant should not cause any nuisance in the surrounding area due to operation of D.G. Set.
- viii. The applicant shall comply with the notification of MoEF dated 17.05.2002 regarding noise limit for generator sets run with diesel
- F) The applicant shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted/displayed to facilitate identification.
- G) The industry shall take adequate measures for control of noise levels from its own sources within the premises so as to maintain ambient air quality standard in respect of noise to less than 75 dB(A) during day time and 70 dB(A) during night time. Day time is reckoned in between 6 a.m. and 10 p.m. and night time is reckoned between 10 p.m. and 6 a.m.

H) Other Conditions:

- 1) The industry should not cause any nuisance in surrounding area.
- 2) The industry should monitor stack emissions and ambient air quality Regularly.

6. CONDITIONS UNDER HAZARDOUS WASTE (MANAGEMENT, HANDLING & TRANSBOUNDRY MOVEMENT) RULES, 2008:

(i) The Industry shall handle hazardous wastes as specified below.

Industry shall not generate any type of hazardous waste.

- (ii) The authorization is hereby granted to operate a facility for collection, storage, transport & disposal of hazardous waste.
- 1. The industry should comply with the Hazardous Waste (M&H) Rules, 2003.
- a. Whenever due to any accident or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.

7. General conditions:

- (i) The applicant shall bring minimum 33% of the available open land under green coverage/ plantation. The applicant shall submit a yearly statement by 30th September every year on available open plot area, no. of trees surviving as on 31st March of the year and no. of trees planted by September end.
- (ii) The applicant shall provide for an alternate electric power source sufficient to operate all pollution control facilities installed by the applicant and operate the same in case of power failure to maintain compliance with the terms and conditions of the consent. In the absence of same, the applicant shall stop, reduce or otherwise, control production to abide by terms & conditions of this consent regarding pollution levels.
- (iii) The applicant shall not change or alter quantity, quality, the rate of discharge, temperature or the mode of the effluent/ emissions or hazardous wastes or control equipments provided for without previous written permission of the Board.
- (iv) The firm shall submit MPCB, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as pre the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992 before 30th September every year.
- (v) The applicant shall install a separate meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained. The applicant shall also submit a comparative statement of designed power and chemical consumptions vis-a vis actual power and chemical consumption along with Environmental statement.
- (vi) Separate drainage system shall be provided for collection of trade and sewage effluents. Terminal manholes shall be provided at the end of collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes/sewers down- stream of the terminal manholes. No effluent shall find its way other than in designed and provided collection system. Neither storm water nor discharge from other premises shall be allowed to mix with the effluents from the factory.

- (vii) The applicant shall provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous wastes to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf. An inspection book shall be opened and made available to the Board's officers during their visit to the applicant.
- (viii) The industry shall ensure that fugitive emissions from the activity are controlled so as to maintain clean and safe environment in and around the factory premises.
- ix) The applicant shall maintain good housekeeping and take adequate measures for control of pollution from all sources so as not to cause nuisance to surrounding area / inhabitants.
- 8. This Board reserves the right to amend or add any conditions in this consent and the same shall be binding on the Applicant.
- 9. The applicant shall comply with the conditions of the Environmental Clearance granted by GOM vide letter No.SEAC-2010/CR-183/TC-2 dtd. 14.10.2010.
- 10. Industry shall submit the Bank Guarantee of Rs. 5/- Lakhs validity up to 31.10.2017 in the Board within 15 days towards operation and maintenance of pollution controlling systems so as to achieve consent standards / and compliance of the same.
- 11. This Consent is issued pursuant to the decision of the Consent Committee meeting dtd. 27.11.2013.
- 12. The Capital investment of the industry is Rs. 30.46 Crs.
