ANDWHEREAS, Your application for renewal of consent to operate for five star Hotel project was put up before Consent Appraisal Committee Meeting held on : 04/12/2013 , ANDWHEREAS, it was decided to issue refusal of renewal consent to operate for non-submission of replies to the letters issued by the Board and Show Cause Notice issued by MPC Board vide letter dated: 23/09/2013.

In view of the aforesaid non compliance, your application for grant of Consent to Establish is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
