With reference to above subject, this office has received your application for Consent to Establish under Section 25 of the Water (Prevention and Control of Pollution) Act, 1974; Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Authorization under Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008, for development of residential project named as "Gagan Lawish" at S.No. 12/2, Pisoli, Pune.

AND WHEREAS, it has been observed that you have started construction without obtaining consent to establish from Board & Environment clearance from competent authority as construction BUA is above 20,000Sq.mtrs.


AND WHEREAS, the Consent Committee in the meeting dated 07/11/2013 has decided to issue refusal of consent to Establish and stop work and power disconnection, as Project proponent has started construction without consent to Establish from Board and environment clearance from competent authority.

THEREFORE, you are hereby directed to stop construction work at the aforesaid site till further orders.

THEREFORE, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
